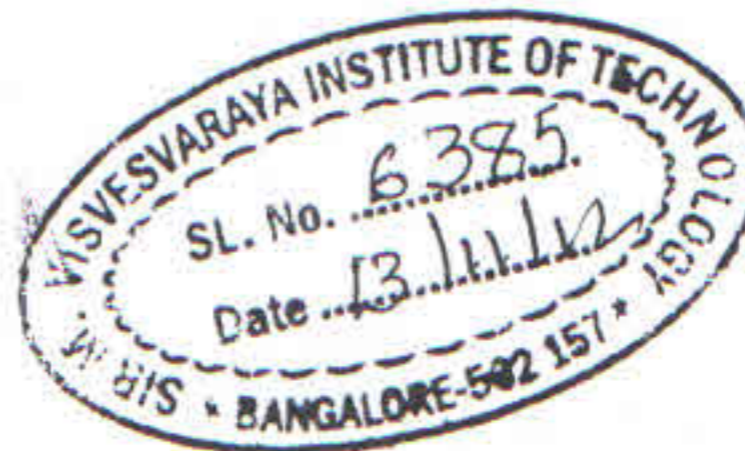

Dear Sir/Madam,

This is with reference to NBA's letter of even number dated 18-09-2012 in which status of accreditation applied by Sir M. Visvesvaraya Institute of Technology, Krishnaderarayanajar, Hunasamaranahalli, Bangalore, for five programmes has been conveyed including the date from which the period of accreditation is valid, based on the decision taken by the Executive Committee of National Board of Accreditation in its meeting held on 28th August 2012 that the duration of accreditation will be academic year-wise. The Executive Committee has subsequently decided that the above decision may be made applicable in respect of the applications of accreditation received in NBA on or after September 11, 2012 i.e. the date of issuance of minutes of the Executive Committee meeting held on 28th August 2012. In case of all applications received prior to September 11, 2012, the validity of period of accreditation may be conveyed from the date of approval by EC.

2. Accordingly, the period of validity of accreditation in respect of five programmes as conveyed under column 4 of para 2 of NBA's letter dated 18-09-2012 may be treated "w.e.f 28-08-2012" instead of "w.e.f. 1st July, 2011".
3. All other provisions of the NBA's letter dated 18-09-2012 will remain unchanged.

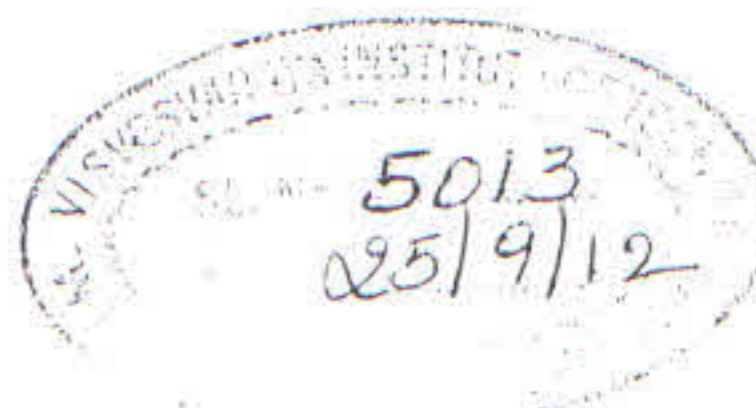

Dear Sir/Madam,

This is with reference to application dated 22-07-2009 from Sir M. Visvesvaraya Institute of Technology, Krishnaderarayanagar, Hunasamarahalli, International Air Port Road, Bangalore, seeking NBA accreditation to the various programmes.

2. An Expert Committee conducted an on-site evaluation of the programmes on 21st to 23rd October, 2011. The report submitted by the Expert Committee was considered by the Engineering Accreditation Evaluation Committee (EAEC) at its meeting held on 27-06-2012. The Executive Committee of the National Board of Accreditation considered the recommendations of EAEC at its meeting held on 28th August 2012. The Executive Committee approved the accreditation status of each programme of the Institute as given in the table below. The Executive Committee has also decided that the duration of accreditation will be academic year-wise. For this purpose the academic year will be considered from July to June. The period of accreditation in col. 4 below has been given accordingly.

3. The accreditation status awarded to the programmes as indicated in the above paragraph does not imply that the accreditation has been granted to Sir M. Visvesvaraya Institute of Technology, Krishnaderarayanagar, Hunasamaranahalli, International Air Port Road, Bangalore as a whole. 7. If the Institution is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
